# **Evidence-informed Decision Making Team Learning and Decision-making Aid**

In 2018, we developed resources to meet our members' needs. Listening to member feedback, we focused on the creation of two large-scale resources – Evidence-informed Decision Making Team Learning Series and a Decision-making Aid. These resources are the first of its kind that we know of in any child welfare system.



# **Team Learning**

Using research and adult learning theory, we have developed an online five-module training series that will increase workers' and supervisors' evidence-informed decision making knowledge and skills. Not only will this resource support the use of research in everyday child welfare practice, but it is also intended to decrease the perception of barriers to research use, increase confidence about research use, address team climate, and promote critical thinking. This module series brings organizational change to life by engaging teams in critical thinking, addressing key evidence, and team and individual exercises.



# **Evidence-informed Decision Making Aid**

Based on our evidence-informed decision making framework, we have created an online Decision-making Aid. This tool will support workers' everyday child welfare decisions and practice. The online tool prompts workers to think about each key area of evidence (case context; child, youth, and family preferences; biases; research evidence). Workers complete the online tool and are then offered a

print-out summary of the information they have inputted. This summary is intended for use in supervision and case conferences. The Decision-making Aid provides a nuanced perspective of the case, allowing workers to see what evidence they have collected, what they still need, how their biases may be impacting the case, and their use of research.

We have developed an implementation plan ready to individualize for each member. We would like to support this implementation plan with a visit from PART staff. We are offering to attend member organizations to meet with workers, supervisors, senior management, and foster parents. Whatever our members need – we are here to support you.



## Closing the knowledge gap

To develop the knowledge base and being a unique method of bringing research to practice, we are evaluating the effectiveness of our team learning module series with the support of a Research Assistant dedicated only to this evaluation. The knowledge that we gain from this evaluation will support our work in the future and generate more effective resources for our members.
