>> LOOKING BACK at 2021/2022

Themes of 2021/2022

Each year, with the help of Link PARTners and stakeholders, PART selects three to four themes that our resources will focus on. Based on survey results, the themes of 2021/2022 were:

- 1. Practice Approaches in Child Welfare
- 2. Children/Youth Coping and Adjustment
- 3. Overrepresented Populations in Child Welfare

The majority of PARTicles and Webinars published in fiscal year 2021 fell into one of these theme categories.

Strategic Plan 2020-2023

With the help of Proforem Inc. and Courage Group International, PART finalized our Strategic Plan for 2020-2023 in 2020. PART continues to find ways to operationalize our strategic plan and are excited to continue implementing changes to our organization to better support the PART community and the children, youth and families that are supported by the child welfare system.

Governance and Bylaws

A review of PART Bylaws took place in 2021 to ensure that the organization and Board is running as intended. Some key changes to our bylaws include:

- 1) Board governance (how the Board is run, and who can be involved)
- Membership base (expanding membership opportunities)
- 3) Updating to include ways to use technology

PARTnerships 2021/2022

We welcomed Dnaagdawenmag Binnoojiiyag Child & Family Services as members of PART this fiscal year. We are pleased to see the desire to build a strong community of evidence-informed practice within the child welfare sector continue to grow across Canada.

National Meetings and Presentations

PART focused on learning more about Ministries and organizations across Canada that may benefit from our services. In 2021, PART presented at the Directors of Child Welfare meeting to begin learning more about the research and EIP needs of each province and territory across Canada. PART is looking forward to exploring more of these opportunities in the next fiscal year.

Focus on Recruiting Foster Parents, Resource Families and Kinship Families to our Resources

Foster parents and kinship families are invaluable resources to our child welfare organizations and system across the country. We have received feedback that many foster parents and kinship families find our resources and services very helpful to the support they offer children, youth, and families. In 2021/2022, focused some of our services to better involve foster families, resource families and kinship families. We saw a large increase in services such as webinars with this population.

Research Projects

In 2021, PART was involved on several calls/round tables with different departments and projects out of the University of Windsor and McMaster University.

Worker Experiences: In 2021 we heard from multiple Senior Leaders within the sector that worker engagement, motivation and satisfaction has been an area of interest to learn more about in the research. We are currently engaged in a project with University of Windsor to explore multiple variables related to practitioners, to improve organizational and service outcomes.

Parenting and Cannabis Use: PART was asked to join two virtual stakeholder dialogues, bringing the Child Welfare Research lens to the McMaster Health Forum regarding upcoming projects on parenting and cannabis use. PART supported the development of an evidence brief that will be utilized across the province.

JoyPOP: PART is supporting several researchers from McMaster complete and submit a PHAC grant for work with the JoyPop app. This project includes both the voices of youth transitioning from care and former youth-in care. This project is a joint project with Child Welfare PAC and Youth in Care Canada. PART has also been involved in the dissemination of project results.

Child Welfare PAC and CAFDN: In 2021, PART supported a cross Canada literature scan of long-term outcomes of children and youth in care. As a country, at the provincial and territorial level, we need to do a better job at collecting standardized short and long-term

outcomes of children, youth and families utilizing services. This project highlighted gaps in our knowledge base.

Community of Practice Meetings

PART held two community of Practice meetings in October 2021 with Link PARTners from our membership. This meeting highlighted new resources and upcoming events at PART, as well as introduced our Themes for 2022. PART staff lead participants through a discussion on Critically Appraising Research and highlighted some new research that has been done in the field (as well as how to use this research in practice). PART staff also did a presentation on Implementing PART at each agency, with some discussion around "Tips and Tricks" to better implement PART/EIP/Research at the organization, supervisory, and individual level (examples below for your reference).



Organizational strategies are aimed to bring awareness to PART and the importance of EIP at the organizational level. These strategies prepare the organization for a shift in their learning culture.

- o Form EIP Committee/Coalition
- o Email Welcome Letter/Registration to all practitioners
- Disseminate Orientation Packages to all practitioners
- o Disseminate Orientation Package to all foster caregivers
- Explicitly Include EIP in Organizational Mission/Vision, and Strategic Planning
- o Intranet Promotion
- Create EIP Committee
- Announcements at Staff Meetings
- Embed Research Use into Organizational and Team Procedures/Practices
- Case conferences
- o Professional Development and Learning Days
- Lunch and Learns

Supervisor Strategies



Research has continuously highlighted the importance of Supervisors in the research use and EIP at an organization. It is important that supervisors buy into the use of EIP, as well as encourage colleagues to utilize PART, research and EIP in practice. Supervisors do not have to be experts in the area; however, they must be an advocate for research/EIP use

- o Introduction to PART Presentation for Supervisors
- o Supervisor Email List to PART or to Link PARTner
- Embed Research Use and discussion of Professional Development and Learning at supervision meetings
- o Embed into supervisory training programs
- o Ensure supervisors engage with research/PART
- Encourage Supervisors to create their own Team Strategies
 - Example: watch a webinar with your team, ask a member
 of your team to bring a journal article to a team meeting,
 encourage the team to refer to research during complex
 cases "what does the research say about that?"



At the individual level, you will see a large range of comfort and acceptance of research use and EIP. Below are some strategies to help the individual practitioner become more familiar and comfortable turning to PART, research and EIP during case decisions.

- Plan a Practitioner Introduction Webinar to PART and EIP with PART Staff
- Plan and run a "lunch and learn" to watch a webinar as an agency (either live or archived)
- Use PART resources as continuous learning opportunities if you are RSW
- Block off 1 hour a week in your calendar at "Research Hours" where you scan current literature in the E-library or set weekly reminders in your calendar to visit the PART website and read a new PARTicle.
- o Share articles that you find interesting with colleagues
- o Attend webinars of interest (live and archived)
- Complete an EIP Map with information from a case of yours.
- Use the Ask a Researcher Resource to have PART Staff collate research for you on a specific topic.

NEW AT PART: Resources

Ask a Researcher-Archived

Our Ask a Researcher resource enables child welfare practitioners to request support from PART staff to interpret research findings, interpret literature and ask about specific areas of practice in the current literature. In 2021, created a space to highlight Ask a Researcher questions that have been asked by colleagues within our membership. The Archived - Ask a Researcher page highlights questions that your colleagues throughout Canada have asked PART and allows all of our members to read through these questions and better understand the topic pertaining to child welfare research. Rapid Reports/Research Reviews

Based on suggestions from the membership, PART began to publish Rapid Report (or Research Reviews). This resource includes written reports that may not have a large enough literature base for a full PARTicle. These reviews are similar to PARTicles (in the fact they are answering research questions), however, they will be shorter, and more practice based. Please see our website for Research Reviews.

MOVING FORWARD into 2022/2023

Focus on Working with Members

PART is looking forward to agency visits in 2022/2023, as these have been halted in the past two years due to COVID. PART will be going on small trips to do in-person presentations and network with potential new members. PART will also focus on position-specific meetings and presentations (ex. Foster/Resource Workers, Students, Supervisors).

Focus on System Collaboration

Families involved with the child welfare system often also are engaged with other public agencies and supports. Collaboration between and among agencies improves service delivery and the experiences of children and families who deal with multiple organizations to address child welfare and safety needs. Interagency collaborations are not only critical in the delivery of services, but also are key to ensuring the sustainable success of the children and families they serve. In 2022/2023, PART is committed to not only continuing to expand across child welfare agencies across Canada, but also with other systems that intertwine with child welfare.

Focus on Resources and Products

PART will explore which products, resources and services that we offer are most beneficial to the members we support. PART will continue to adapt our resources to better support the ever-changing field of child welfare, and work to better understand other resources that our members may need. Please continue to inform PART staff about the ways in which practitioners and resource workers at your agencies prefer to learn and what you may find beneficial at your organization.

- 4. Socioeconomic Status and the Intersection with Child Welfare

The majority of PARTicles and Webinars published in fiscal year 2022/2023 will fall into one of these theme categories. If new and exciting research is published outside of these areas, OR we receive feedback from the child welfare sector that a new topic would be of interest to practitioners, PART will make exceptions.

Focus on Indigenous Ways of Knowing and Research

Historically research in many fields, including child welfare research, has failed to engage Indigenous peoples and organizations as primary stakeholders and beneficiaries to evidence from the research. Until recently, Indigenous community perspectives on research priorities, project development, and results were often ignored or marginal. In some cases, research proceeded without informed consent, results were interpreted with minimal context, and findings have often depicted Indigenous communities in a more deficit-based ways as opposed to strength based ways. This upcoming fiscal year, PART will continue to challenge colonial methods of research when it comes to the experiences and voices of Indigenous children, youth and families in research.

PART will also begin to highlight and explore similarities between Indigenous Research Methodologies and Evidence-informed Practice. Ways of knowing or learning that are outside of colonial approaches to science have often been regarded as ideological or inconclusive because methodologies do not fit within the positivist paradigm. PART will challenge the cognitive imperialism in institutions that has privileged Eurocentric or colonial methods above other types of knowledge acquisition.

Focus on PART's Commitment to Reconciliation

PART continues to identify ways to actively contribute to bringing Indigenous truths in Child Welfare Research and Practice.
