EVIDENCE-INFORMED DECISION-MAKING

Looking back...

Over the past year we have been focused on evidence-informed decision-making. This theme arose as a result of feedback from our members - we heard that PART resources are informative, but that workers would benefit from support in bringing the research to practice. So, to meet your needs we have focused on the following key areas:



Senior Leader Event

This event focused on senior leaders' role in promoting and sustaining evidence-informed practice. Our esteemed presenters – Dr. Nico Trocmé, Dr. Fred Wulczyn, Dr. Bowen McBeath, and Chris Steven offered needed information and experience to support senior leaders understanding of their role in helping their organization become evidence-informed.

On the use of research evidence...

Evidence-informed Decision-making Event

This event brought child welfare practitioners and supervisors information on the importance of using critical thinking and research in decision-making through the experiences of Ashley Jack – a young person who has experienced out-of-home care. We also had some excellent presentations from Dr. Eileen Gambrill, University of Berkeley California, and Dr. John Lavis, McMaster University, WHO, and Harvard University.

Evidence-informed Decision-making Guidebook

This guidebook is an easy to read, step-by-step guide for child welfare workers and supervisors aiming to increase their evidence-informed decision-making skills, including the use of research in practice.

Looking ahead...

We remain focused on supporting members' use of research in practice and critical thinking skills throughout the decision-making process. We continue to bring you webinars, PARTicle literature reviews, peer reviewed studies, guidebooks, learning events, and much more.



To increase your use of PART resources we are currently working on a module teaching series that can be watched during team meetings. Each module will include short videos, team exercises, and information to increase understanding and use of research in practice.



Finally, we are currently developing an online decision-making aid. This aid will support critical thinking and the application of research to practice in the key decisions that child welfare workers engage in on a daily basis. We are very excited about these new resources, as we are the only child welfare knowledge translation organizations offering these resources. Stay tuned....
